1. POLICY STATEMENT

ASCI is committed to operating in a way that protects the environment, complies with legal and contractual requirements, and promotes continuous improvement across our operations. - Following environmental procedures to avoid degradation, contamination, and resource waste
- Integrating environmental awareness into daily decisions and long-term planning

This policy also reflects ASCI's commitment to a collaborative culture, aligning with ISO 30415:2021. We value diverse perspectives and respect the rights and interests of local and Indigenous communities. We believe environmental protection is a shared responsibility, strengthened through inclusive decision-making and transparent communication.

2. SCOPE

This policy applies to

- All subcontractors working with any ASCI entity, regardless of contract type or duration.
